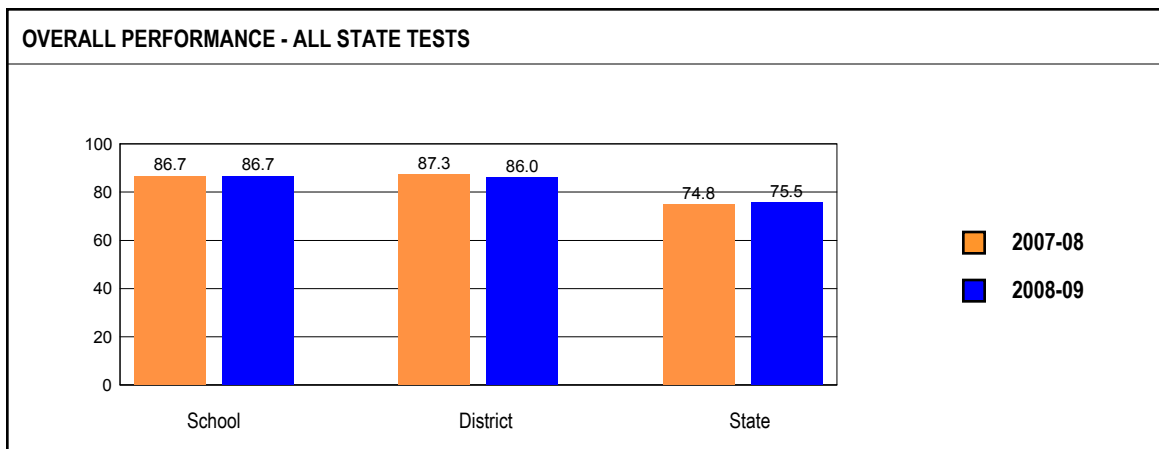

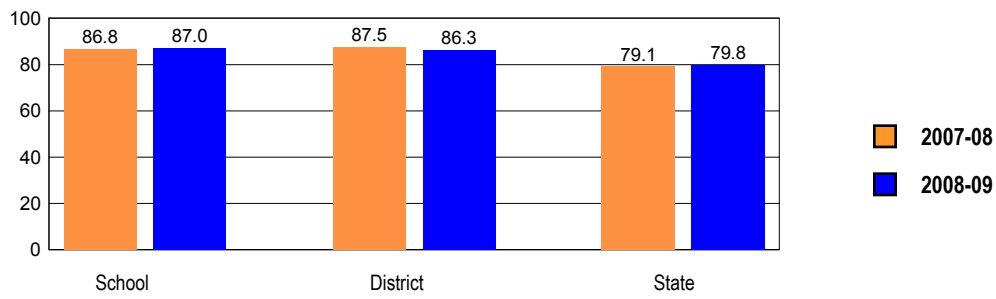
### OVERALL STUDENT PERFORMANCE

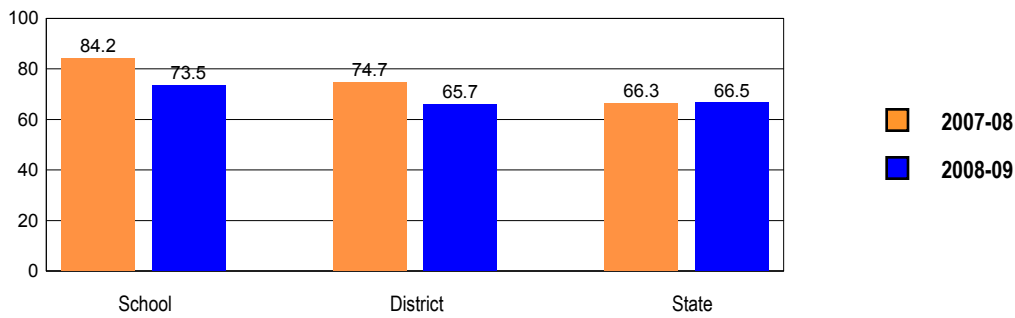

**OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE**



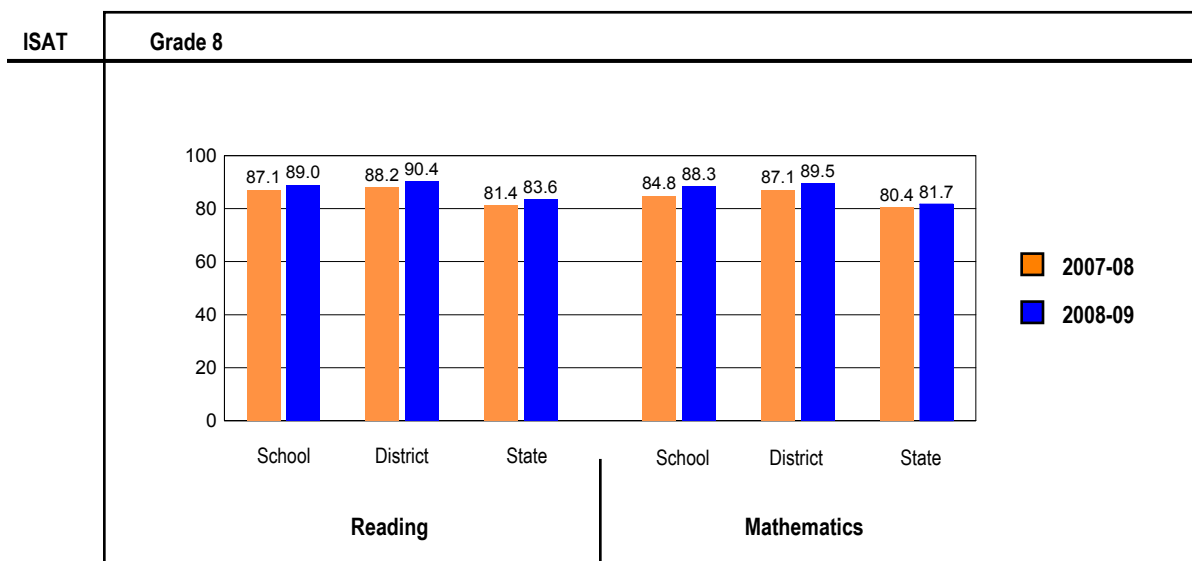
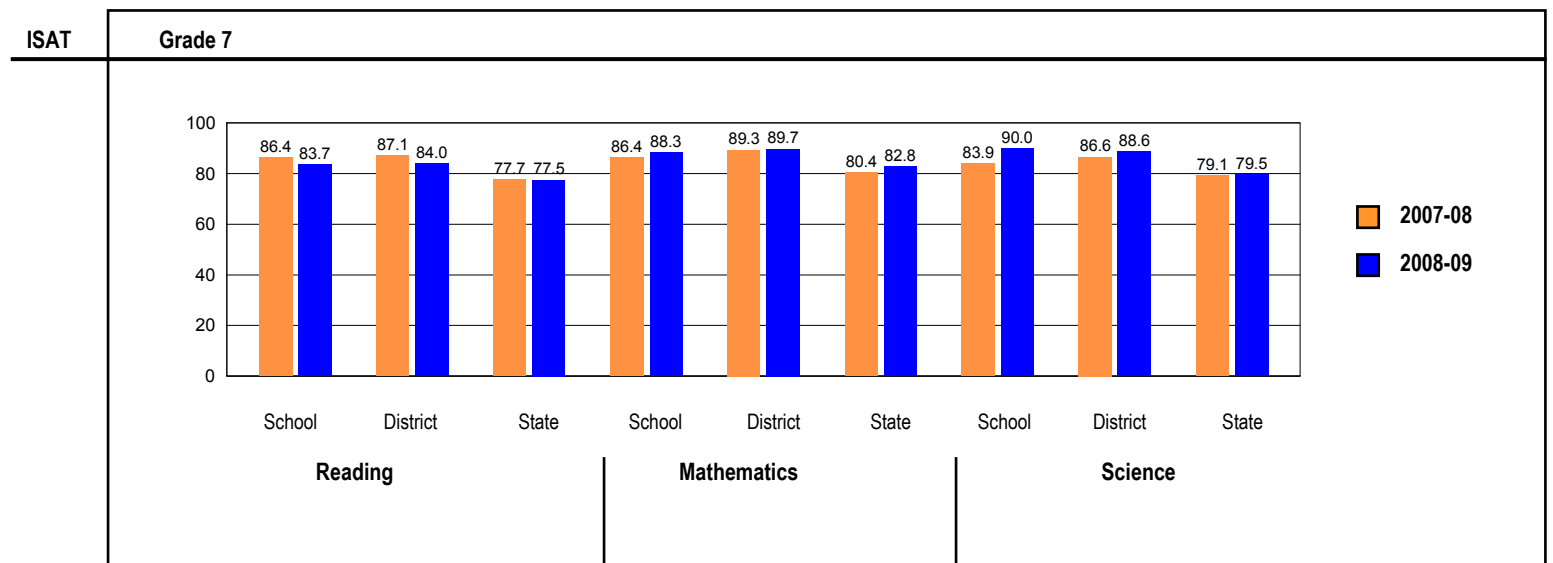
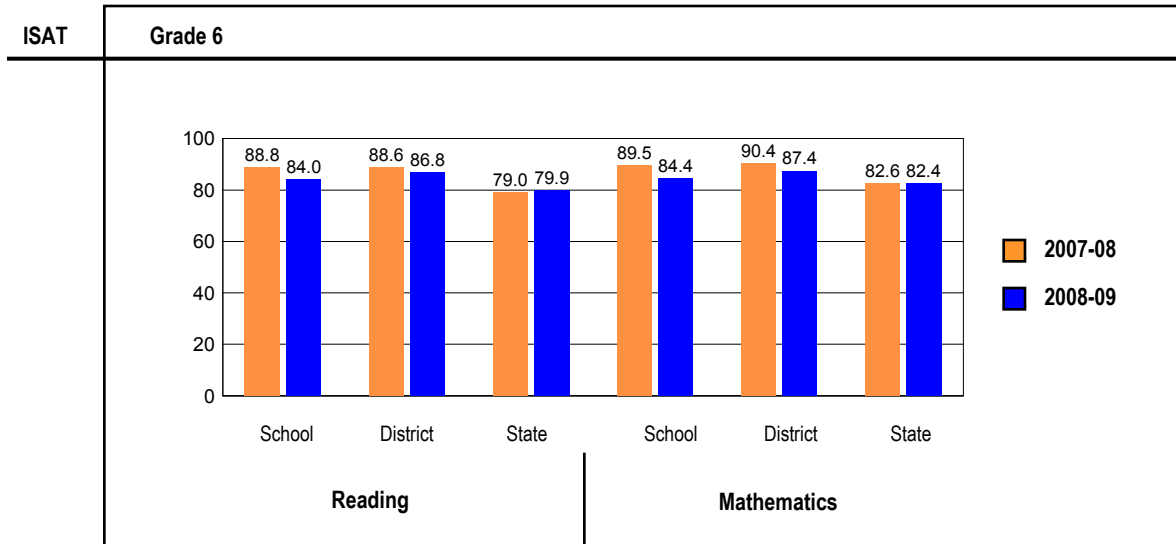
**OVERALL ILLINOIS ALTERNATE ASSESSMENT (IAA) PERFORMANCE**

**ISAT PERFORMANCE**

## PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

**ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)**

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

**Four Conditions Are Required For Making Adequate Yearly Progress (AYP):**

1. At least 95% tested in reading and mathematics for every student group. If the current year participation rate is less than 95%, this condition may be met if the average of the current and preceding year rates is at least 95%, or if the average of the current and two preceding years is at least 95%. Only actual participation rates are printed. If the participation rate printed is less than 95% and yet this school makes AYP, it means that the 95% condition was met by averaging.
2. At least 70.0% meeting/exceeding standards in reading and mathematics for every group. For any group with less than 70.0% meeting/exceeding standards, a 95% confidence interval was applied. Subgroups may meet this condition through Safe Harbor provisions. \*\*\*

During the 2008-2009 school year, the Stratford Building Leadership Team and staff focused on strategic planning goals in the areas of reading and math, improving school climate, and developing a new master schedule for the 2010-2011 school year, which will include additional instructional minutes for all subject areas.

**2008-2009 ISAT Performance Data**

- 84.0% of 6th grade students met or exceeded state standards in the area of reading.
- 84.4% of 6th grade students met or exceeded state standards in the area of math.
- 83.7% of 7th grade students met or exceeded state standards in the area of reading.
- 88.3% of 7th grade students met or exceeded state standards in the area of math.
- 90.0% of 7th grade students met or exceeded state standards in the area of science.
- 89.0% of 8th grade students met or exceeded state standards in the area of reading.
- 88.3% of 8th grade students met or exceeded state standards in the area of math.

**Goals for Improvement: 2009-2010**

During the 2009-2010 school year, Stratford's Building Leadership Team and staff will focus on the following goals for instructional and school improvement.

- **Concentrate on the areas of math and reading instruction across the curriculum through use of differentiated instruction and supplemental intervention programs.**
- **Staff members will work diligently on curriculum design for the new middle school schedule which includes increased instructional minutes for all subject areas.**

**Key Strategies for Achievement of Goals**

- The focus for all District 93 schools this year will be on Tier I interventions. Tier I interventions are implemented to support all of our students in addition to our curriculum.
- Stratford will be researching and piloting additional intervention and assessment programs, such as Odyssey and AIMSWeb. In addition to these programs, teachers will continue to analyze NWEA MAPs testing scores and other local assessments to drive instruction and monitor and track progress.
- The Positive Behavior Interventions and Supports model will continue to be a guideline to focus on the school climate and correlate with our Character Counts program and Response to Intervention.
- Additional resources for students with disabilities will be utilized to support their academic progress in the area of math.
